BELOW ARE IMPORTANT NOTES relevant to the interpretation of data displayed in this bulletin:

- Episode dates are defined by dates of illness onset. When those dates are unavailable, earliest laboratory date is used (collection or result date); if also unavailable, then public health care report date is used. Analyses based on episode date (or illness onset date) may better represent the timing of epidemic evolution. Episode-based tallies for recent weeks are expected to increase as case data, in particular onset dates, are more complete.
- The weekly tally by surveillance date (result date, if unavailable then report date) includes cases with illness onset date in preceding weeks. Episode dates for hospital admission, ICU, and death are defined by admission and death dates. When unavailable, surveillance date is used.
- Per capita rates/incidences are based on PEOPLE2020 population estimates (n=5,139,568 for BC overall).
- Laboratory data include Medical Service Plan (MSP) funded (e.g. clinical diagnostic tests) and non-MSP funded (e.g. screening tests) specimens.
- Case data were extracted on May 14, 2021 and laboratory data on May 17, 2021

A. COVID-19 case counts and epidemic curves

Provincially, from week 3 2020 to week 18 2021, there have been 136,784 cases, corresponding to a cumulative incidence of 2,658 per 100K (Table 1, Figure 1). As shown in Figure 1, after peaking in week 14 at 152 per 100K, incidence has steadily decreased to 72 per 100K in week 18. Rates may increase further as data by episode date become more complete.





Figure 2. Weekly episode-based incidence rates by HA and health service delivery area (HSDA), BC March 01, 2020 (week 10) - May 08, 2021 (week18) (N= 136,784)

As shown in Figure 2, incidence decreased in all health authorities over the past 4-5 weeks. From week 14 to week 18, Fraser Health (FH) incidence decreased from 220 to 129 per 100K and Interior Health (IH) incidence decreased from 86 to 34 per 100K. Incidence decreased from week 13 to week 18 in Vancouver Coastal Health (VCH), from 194 to 58 per 100K; in Island Health (VIHA), from 48 to 11 per 100K; and in Northern Health (NH), from 120 to 32 per 100K. Incidence decreased in all health service delivery areas starting in weeks 10-16, with the largest declines in Northwest, Northeast and Northshore/Coast Garibaldi. Rates may increase as data become more complete.


B. Likely sources of infection

As shown in Table 2 and Figure 3, domestic contact with a known case or cluster has been the most commonly reported source of infection across the pandemic to date.

C. Test rates and percent positive

As shown by the darker-colored bars in Figure 4, testing of MSP-funded specimens decreased from ~67,500 specimens in week 14 to ~51,000 in week 18. Positivity of MSP-funded specimens decreased from 12.0% in week 14 to 9.0% in week 18.





Figure 5. Testing rates and percent SARS-CoV-2 positive by health authority and collection week, BC March 15, 2020 (week 12) – May 08, 2021 (week18)

As shown in **Panel A** of <u>Figure 5</u>, the per capita testing rates for MSP-only specimens recently decreased in all HAs. Testing rates have decreased in VCH, IH, NH and VIHA since week 14 and in FH since week 15. As shown in **Panel B**, percent positivity for week 18 MSP-funded tests is highest in FH at 11.2% followed by VCH at 8.7%, NH at 8.6%, and lowest in IH and VIHA at 5.0% and 2.6%, respectively. Percent positivity has decreased in all HAs since weeks 13-14, most notably in NH.

D. Age profile – Testing and cases

Testing rates and percent positivity by age group




Figure 6. Average weekly SARS-CoV-2 testing rates and percent positive by known age group, BC January 20, 2020 (week 4) – May 08, 2021 (week 18)^a

As shown by the bars in **Figure 6**, testing rates in week 18 (shown in red) have decreased in all age groups since peak testing rates in weeks 14-17 (shown in grey bars). The highest testing rates in week 18 were in 5-9 year-olds and 20-39-year-olds.

As shown by the black dots in Figure 6, the percent positivity for MSP-only specimens has remained stable or decreased in all age groups since weeks 13-15. Most prominently, the percent positivity in the 10-14-year-olds has seen the sharpest decline since week 13 and, in the 5-9-year-olds, since week 14. In week 18, the highest percent positivity was in the 15-19-year-olds followed by 20-30-year-olds and 40-59-year-olds, at 11.2%, 10.6% and 9.2%, respectively.

Case distribution and weekly incidence by age group

As shown in <u>Figure 7</u>, the percentage contribution of age groups 40-49 and 60-69-year-olds decreased by 1.1% and 1.3% respectively, and was met mainly by an increase of <1% each for age groups <40 years. The remaining age groups' contributions remained relatively stable.





Figure 8. Weekly age-specific COVID-19 incidence per 100K population by epidemiological week, BC January 15, 2020 (week 3) – May 08, 2021 (week 18) (N= 136,761)

As shown in **Figure 8**, all age specific incidences decreased from weeks 13-15 to week 18. Most notably, 15-19-year-olds, 20-29-year-olds and 40-49-year-olds peaked in week 14 and have seen the sharpest decline up to week 18 from 219 to 108 per 100k, 257 to 120 per 100k and 176 to 75 per 100k, respectively. Since week 13, 30-39-year-olds also experienced a sharp decrease from 201 to 99 per 100k. Week 18 age-specific incidences are likely to increase as data become more complete.

E. Severe outcome counts and epi-curve

The number of weekly hospital admissions peaked in week 15 (384) and has declined since then, reaching 273 admissions in week 18. The number of intensive care unit (ICU) admissions also peaked in week 15 (109) and has decreased since then, reaching 63 admissions in week 18. The number of deaths has been stable from weeks 7 to 18 with an average of 25 deaths per week (Table 3, Figure 9). These numbers may increase in future reports as more data become available.


Cumulatively, there have been 11 confirmed cases of <u>Multi-system Inflammatory Syndrome in children and adolescents</u> (<u>MIS-C</u>) in BC since January 1, 2020 (no new confirmed cases since last report). The median age of these cases is 6 (range 1-15) years.

F. Age profile, severe outcomes

Table 4 displays the distribution of cases and severe outcomes as well as the BC population for each age group. In week 18, median age of hospital admissions, ICU admissions and deaths was 55 years, 58 years and 77 years, respectively (data not shown).




Figure 10. Weekly age-specific COVID-19 deaths by episode date, BC January 15, 2020 (week 3) - May 08, 2021 (week 18) (N= 1,623)

As shown in Figure 10, following increasing vaccination rates in the elderly, the weekly number of deaths in 80+ year-olds decreased by 88% between weeks 50 and 13 (from 85 to 10 deaths), with a slight increase in weeks 14-16 (~17 deaths per week); and a renewed decline in week 18 (11 deaths). Similarly, the number of weekly deaths decreased in 70-79-year olds by 87% between weeks 51 and 7 (from 23 to 3 deaths) and has remained stable in weeks 8-18, with an average of 7 deaths per week. The weekly number of deaths in the 60-69-year-olds has remained small and fluctuated from week to week in 2021 (between 0 and 8 deaths).

In week 18, 145/3,692 (4%) cases, 48/273 (18%) hospitalizations, 15/63 (24%) ICU admissions, and 20/26 (77%) deaths were in 70+ year-olds (data not shown).

G. Care facility outbreaks

As shown in **Table 5** and **Figure 11**, 316 care facility (acute and long-term care setting) outbreaks were reported in BC to the end of week 18, with no new outbreaks in the past 2 weeks. Outbreaks in long-term care settings (i.e. long-term care or assisted living facilities) have decreased since week 51 and outbreaks in acute care facilities have decreased since week 9.

Five (19%) of the 26 deaths reported in week 18 were associated with an outbreak in a long-term care setting. This compares with a peak of 94 (81%) of 116 deaths associated with a long-term care outbreak in week 50.

Figure 12 displays a decrease in long-term care setting resident cases 70+ years of age as opposed to other cases of the same age group following the start of the vaccination of the LTCF population in week 51. Since week 5, there has been an average of 8 cases per week for long-term care setting residents 70+ years of age. In contrast, cases among community-dwelling 70+ year-olds decreased in weeks 13 to 18, from 384 to 141 cases, following the vaccination of community-dwelling adults aged 70+ years starting in weeks 8 to 14.


Figure 13 shows a larger decrease in long-term care setting resident deaths 70+ years of age as compared to deaths in the same age group outside of these settings following the start of the vaccination of the LTCF population in week 51. Since week 7, there has been an average of two deaths per week within long-term care these settings, while there has been an average of 17 deaths per week in 70+ years outside these settings. There has been a decrease in community dwelling case deaths in weeks 17-18. This number may increase in future reports as more data become available.







Figure 13. COVID-19 long-term care setting resident^a deaths (n= 642) vs other deaths (n= 555) ≥70 years of age, by episode death date, BC <u>September 13, 2021 (week 38</u>) – May 08, 2021 (week18)
