Re: Revisions to Communicable Disease Control Manual, Chapter 2 –

Immunization Program

Please note the following changes to the Communicable Disease Control Manual, Chapter 2 – Immunization Program:

(1) Section I – Introduction

Pages 7 – 9 and 9a (new page), "History of Immunization Development in BC:"

- Addition of biological product names where necessary for clarity
- Addition of new vaccine program start dates, by month
- Addition of vaccine program changes for 2004 and 2005

(2) Section II – Immunization Schedules

Page 2, Basic Immunization:

Footnote for ♦ has been restored

Page 8, "Minimum Intervals Between Vaccine Doses:"

The schedule for meningococcal C conjugate vaccine is specific to Neis Vac-C

Page 9, "Vaccines Recommended for High Risk Clients:"

• Islet cell transplant recipients have been added to the list of high risk clients

(3) Section III – Contraindications and Precautions to Immunization

Page 8, 8.3: Prematurity

The response to a birth dose of hepatitis B vaccine in a preterm infant with a birth weight of < 2000 grams may be diminished. These infants will require a 4 dose hepatitis B vaccine series.

Page 9, 8.6: Immunization and Breastfeeding

Varicella vaccine can be given to a breastfeeding woman.

(4) Section VII – Biological Products

Pages 5, 35, 37, 39, 41, 43, 43a:

 Islet cell transplant recipients have been added to the list of persons eligible for these vaccines (Act-HIB®, Meningococcal C Conjugate, Meningococcal Polysaccharide, Pneumococcal Conjugate, and Pneumococcal Polysaccharide).

Page 11, Hepatitis B immune Globulin:

Wording change for clarity under Indications (number 3).

Page 14, Hepatitis B Vaccine Pre-exposure Indications:

Addition of HIV positive individuals to this list

Page 31, Influenza Vaccine Indications:

New group eligible for publicly-funded influenza vaccine: people working with poultry and/or swine (due to potential animal infection with avian or swine influenza).

Page 32a, Vaxigrip®:

- Added dosing of Vaxigrip for those 3 8 years and ≥ 9 years of age.
- New footnote⊕. While Vaxigrip® is to be routinely used for children 6 23 months. high risk pregnant and lactating women, and women in their 3rd trimester expected to deliver during the influenza season, Vaxigrip® may be administered to other eligible groups in order to use up remaining doses in a vial post-puncture.

Pages 35, 37, and 38:

Clarified wording related to scheduling of infant doses

Page 50a and 50d (RabAvert®):

More detailed instructions for reconstitution of the vaccine

Page 50b (RabAvert®):

Contraindications moved to this page from page 50a
