Re: Revised Rabies Control Guidelines (CDC Manual – Chapter I,

Management of Specific Diseases, Rabies; and Chapter II,

Immunization Program)

Please note the following revisions to the CDC Manual - Rabies:

Page 3:

paragraph lists rabies vaccines used in other countries that meet WHO requirements for safety, potency, and efficacy.

Page 5, Subsection 4.2 "Have first aid and wound care been performed:"

recommends use of soap and water only for cleaning, and not the previously listed agents due to their ability to cause tissue irritation and damage.

Page 7, Subsection 4.8 "Did the animal exhibit signs compatible with rabies:"

added a note pertaining to provoked and unprovoked animal behaviour. In areas where rabies is endemic in a specific animal species, do not consider that animal's biting behaviour as provoked or unprovoked. Consider the animal as potentially infectious for rabies.

Page 10, Section 7.0 "Recording:"

• 5th bullet: when iPHIS cannot be accessed, new instruction is to fax the "Rabies Exposure Report and Rabies Biologicals Request Form" to the Biologicals Desk. BCCDC will enter this information into iPHIS on your behalf. The information is needed for monitoring the epidemiology of rabies in BC and the utilization of RPEP.

Page 11, Section 9.0 "Simian B Virus:"

 more detailed information on this issue will soon be included in a new section. of the CDC Manual, Chapter I – Management of Specific Diseases, Simian B Virus.

Page 19, Appendix E: Record of Rabies Vaccine and Rabies Immune Globulin Administration:"

added space to record the administration of rabies vaccine
