Page 4: 3.0 Schedule B

Correction to vaccines indicated one month after initial visit (DTaP-IPV)

Page 6: 5.0 Schedule D

Post-secondary students are eligible for a second dose of MMR vaccine

Page 7: 6.0 Schedule E

Post-secondary students are eligible for a second dose of MMR vaccine

Page 8: 7.0 Minimum Intervals Between Vaccine Doses

- Link for conjugate Pneumococcal vaccine has been revised
- Three dose Pneumococcal conjugate schedule added
- Footnote to clarify that Varicella second dose is for children ≥ 13 years of age

Section VII – Biological Products:

Page 34: Measles, Mumps, Rubella Vaccine

- 1956 reinserted as the date for determining need for vaccine for health care and child care workers
- Second dose MMR vaccine publicly-funded for post secondary students
- 2 month spacing for rubella testing or administration post-partum to rubella susceptible women

Page 41: Pneumococcal conjugate vaccine

 Clarification of schedules: schedule for Aboriginal infants is the "healthy" infant schedule

Page 41a:

 New table, COMPLETING A CONJUGATE PNEUMOCOCCAL VACCINE SERIES, replaces the "interrupted schedule" table from Section II, and the "delayed" schedule from this page
