Please note the following changes to the Communicable Disease Control Manual – Chapter 5 Sexually Transmitted infections:

(1) Corrections to administrative circular 2012:02

Please note the following corrections to DSTs released on February 7, 2012:

- Proctitis Decision Support Tool page 4 dosing for azithromycin should read give 1 gm PO in a single dose. Remove the repeated dose of azithromycin in one week.
- Proctitis Decision Support Tool page 5 table formatting updated
- Epididymitis Decision Support Tool page 4 updated note #8 under treatment table to read "Use of doxycycline as the first choice is preferable in the treatment of epididymitis due to its increased effectiveness for the co-treatment of Chlamydia". Removed from note #8.
- Epididymitis Decision Support Tool page 7 updated under "Consultation and Referral" – removed sentence "Refer all clients who are pregnant or breastfeeding".
- Pelvic Inflammatory Disease Decision Support Tool page 3, diagnostic testing updated to remove word proctitis - now reads "offer clients presenting with symptoms of PID"
